- 1. Manuscripts contributed must not have been published in any other journal and must be written in Japanese or English in accordance with the guidelines for contribution.
- 2. Manuscripts pertaining to medical research involving human subjects must satisfy the principles given in the Declaration of Helsinki. If the manuscripts pertain to animal studies, these studies must have been carried out ethically in accordance with the Guidelines on Animal Studies Prepared by the Relevant Research Institutes.
- 3. Acceptable categories of manuscripts are review papers, original papers, case reports, abstracts and others. Review papers are confined to those written in response to a request from the Editorial Board, as a rule.
- 4. The fees for publication, set forth by the Japanese Society of Periodontology, must be paid.
  The fees for publication of review papers in memory of awards or case reports in memory of awards are set forth separately.
- 5. This journal is published 6 times each year. Two of the 6 volumes are special issues published by the Japanese Society of Periodontology. The special issues include abstracts of presentations made at meetings of this society.
- 6. The date of publication is March 28 for Number 1, June 28 for No. 2, September 28 for Number 3 and December 28 for Number 4 of each volume. The deadlines for contribution are November 10, February 10, May 10 and August 10 for Issues No. 1, 2, 3 and 4 of each volume, respectively. Special issues are published according to the schedule of the meetings of the Japanese Society of Periodontology.
- 7. The date when a manuscript has been received via the Internet is deemed as the date of receipt.

- 8. Acceptance/refusal of each manuscript for publication and the order of publication are determined after review by the Editorial Board. The date of receipt and the date of acceptance are printed for each manuscript published in the journal. Manuscripts returned by the Editorial Board to the authors for reasons pertaining to rewriting, correction, postponement, etc. may be excluded from the publication schedule.
- 9. As a rule, proofreading of the manuscript by the author(s) is done twice, at a maximum.
- 10. As a result, manuscripts need to be contributed via the Internet (http://ess.jstage.jst.go.jp/contrib/PERIO/initialsubmission/)
- 11. The copyright and the right for photocopy of all material published in this journal belong to this society. The society may reproduce or publish the whole or any part of these materials through various media, including networks.
